Duty ExemptionImport Duty Act Cap 91

Duty exemption is a government support scheme provided by DoI and Dept. of Customs & Inland Revenue in pursuant to the Vanuatu Customs tariff under code 010. This enables manufacturers to apply/renew duty exemption on importing raw materials, packaging materials, and equipments purposely for manufacturing activities at a fee of 11,500vt per form and valid for one year. Forms can be collected at the DoI Office.

Industrial Permit

Industrial Development Act No 19

To be eligible for duty exemption, any individual operating an industrial undertaking and internationally traded services in Vanuatu must have a valid **Industrial Permit** as regulated under the Industrial Development Act No. 19 of 2014. Industrial permit fee is

2250vt and is valid for a period of 5 years. Application form can be collected at the Dept. of Industry.
